NADAC events are relaxed and fun. Please come perpared to have FUN with your dog, smile, and complete the day with new friends!

If exhibitors come out to help build courses and set jump bars then the trial will run quite efficiently. If no one helps, then as main workers get tired, the trial will run late and slow. We will be very generous with worker tickets for those who volunteer to help thoroughout the weekend. Your tickets may be redeemed for food and beverages at the trial, or for future entries and ring time to train on non-trial dates.

ABOUT THE NADAC Video Tape (VT) PROGRAM:

Qualifying points earned via VT runs will be credited toward titles, special awards and entry into the Championships.

Note: Fifty percent (50%) of the points earned in each class requirement for a NATCH or Versatility NATCH must be earned from a traditional NADAC trial. Additionally, fifty percent (50%) of the points required for eligibility into the Championships must be earned from a traditional NADAC trial.

NADAC will post a new set of courses each week. People with NADAC registered and eligible dogs can run courses and submit videos. All titling options will be available.

NADAC rules prevail as does sound ethics and good sportsmanship. Please refer to the [Exhibitors Handbook](#) for a complete description of the rules.

- The first run of a VT course is the one to submit for review. Subsequent runs may be used for practice.
- Contacts must be clearly visible from the camera angle and the entire run must be clearly visible from start to finish.
- The dog must come to the start line with a leash on; they must run with no collar and, they must leave the course area on leash, without tugging or getting any treats.

Training in the ring will be allowed, just as it is during any traditional trial weekend. Because these events tend to be much smaller than a regular trial and we do not have a judge waiting to review the next run in real time, we will allow more than one attempt at a particular equipment performance or sequence.

ENTRY FEES:

Entry fees are \$30 per dog per day – you may run as many classes as you like. We will attempt to offer at least 7 classes per day: 2 x Regular, 1 x Chances, Jumpers, Touch N Go, Tunnelers, and Weavers. If a numbered Hoopers course is also published, we will offer that.

DAY OF SHOW ENTRIES WILL BE CHARGED \$40 per DAY. PLEASE ENTER IN ADVANCE!

The first three qualifying runs for a dog will be submitted to NADAC on your behalf. If your dog qualifies on more than three runs, we will ask for \$10 per additional run submitted to NADAC. This additional fee covers hard costs associated with submitting the VT files. NADAC charges \$5 per run to review the qualifiers and record the points, we ask for \$5 per run for the service of recording, uploading, and submitting the run details.

Those who are participating in the K9 Corps Agility Membership Program run free for the dog(s) that are enrolled as members.

INTRO LEVEL

Intro level courses are shorter than Novice. The only Intro level class with weaves will be Intro Weavers and it will have one set of 6 poles; no other Intro classes will present weave poles. The Intro level will have no tunnel/contact discriminations.

The Intro level is a full titling level with the basic titles at 30 points, Outstanding Performance at 60 points and Superior Performance at 100 points for Chances, Jumpers, Tunnelers, Weavers, Hoopers, Touch N Go, Barrelers, and Extreme Hoopers. For Regular the basic title is at 30 points, Outstanding Performance is at 100 points and Superior Performance is at 200 points.

THIS IS A CONTAINERIZED EVENT

FOOD/TOYS IN POCKET: Food or a small noiseless toy may be carried into the ring in your pocket provided it is contained in a ziplock bag or small container such as a pill bottle. The container cannot be visible in the ring nor within 10 feet of the ring. You cannot indicate to your dog that you have this item on you i.e. patting your pocket. You are not allowed to remove the container until you are at least 10 feet outside the ring. All food and toys must be contained on the property and none can be left lying about loose. This policy has been implemented to reduce the possibility of dogs fighting over loose food or toys, diminish dogs dragging their handlers back to their crates (or wherever they left their food), and to lessen the amount of insects that are around loose food.

HOSPITALITY

- We offer a complimentary variety of pastries and beverages for breakfast each morning.

EVERYTHING YOU COULD POSSIBLY WANT TO KNOW ABOUT JUMP HEIGHTS

Dogs must enter the Veterans Division after their 9th birthday.

Dogs must enter the Skilled Category, Veterans Division after their 12th birthday.

SKILLED CATEGORY

When entering the Skilled Category, all dogs must jump 4" lower than their Proficient, Standard Division jump height requires.

NON-JUMPING CLASSES: VETERAN OR DISABLED HANDLER

Handlers who are 60 years or older, or who have a disability that restricts mobility, may choose to enter the non-jumping classes as a Veteran Handler and receive 10% more standard course time. This option is for Veteran/Disabled handlers in the non-jumping classes only. The Veteran/Disabled Handler division is designed for handlers who, due to age or impairment, are mobility limited and need extra time to guide their canine partners through an agility course. When entering as a Veteran/Disabled Handler, you must enter all dogs in all classes for the entire trial in this Division and must jump 4" lower than your Proficient Standard Division jump height requires. In the non-jumping classes, dogs will be scored and placed with their Standard Division jump height.

MEASURING:

Dogs which require measuring:

- Dogs in the Proficient Category, Novice, Open or Elite jumping 4", 8", 12" or 16"

Dogs which do not need to be measured:

- Dogs jumping 16" in the Veteran or Junior Handler Division
 - Dogs jumping 20" and 20+
 - Dogs in the Skilled Category
 - Dogs with a permanent height card
 - Dogs listed on the Height Exemption List

INTRO LEVEL:

Dogs entered at the intro level may jump at any height below or equal to their Standard Proficient jump height. 0 inches is not considered a valid jump height.

AGREEMENT

The person who signs this agreement represents that he/she is authorized to enter into this agreement on behalf of both exhibitor and the owner of entered dog. In consideration of acceptance of this entry:

1.1 As used here NADAC means North American Dog Agility Council, its members, officers, directors, employees, show chairs, show committees and agents.

1.2 Exhibitor/owner, agree to abide by the rules and regulations of NADAC and any other rules and regulations appearing in the premium for this event.

1.3 Exhibitor/owner certify that the entered dog is not a hazard to persons, dogs or property and that the entered dog's rabies vaccination is current in accordance with the requirement of the state in which the dog resides.

1.4 Exhibitor/owner acknowledge all hazards presented by the event and the event premises, including but not limited to, the condition of the floors, stairways, halls, lighting, security measures or lack of, electrical appliances, fitting, show rings, parking areas and the presence of unfamiliar animals and people; exhibitor and owner assume the risk of any harm arising from these.

1.5 Exhibitor/owner release NADAC (Including NADAC officers directors, employees and members), K-9 Corps Agility (including officers, directors, employees, and volunteers) and will defend them and hold them harmless from all present and future loss, injury, damage, claims, demands and liabilities involving the entered dog, the event or event premises. Without limiting the generality of the foregoing hold harmless provisions, exhibitor/owner hereby specifically assume sole responsibility for and agree to indemnify and save aforementioned parties harmless from any and all loss and expenses (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damages because of bodily injuries, including death, at any time in consequence of my (our) participation in this event, howsoever such injury or death may be caused and whether or not the same may have been caused or may have been alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents or any other persons.

DIRECTIONS:

The best way to find us is by using the “Directions” feature of Google Maps. Some GPS units will not recognize the addressing system here in Outagamie County.

In general, we are located about ¼ mile east of a roundabout at the intersection of Highway 76 and County Road O. We're North of Greenville, east of Hortonville, northwest of Appleton.

FROM THE NORTHEAST OR SOUTH (Green Bay, Oshkosh, Milwaukee):

- Take US 41 to the WI Highway 15 (OO - Northland Avenue) exit.
- Proceed west on WI 15 to WI Highway 76 in Greenville, then turn right.
- You will continue north to the roundabout at County O, right on O to the third property on your right.

FROM THE NORTHWEST (Wausau, Eau Claire, Minneapolis)

- Take I-94 to WI Highway 29 Eastbound.
- Follow 29 East to Highway 45.
- South on 45 through the community of New London to Mill St. (WI Highway 15).
- Turn left on Mill Street and proceed southeast past the community of Hortonville and in to Greenville until you come to the traffic signal at WI Highway 76.
- Turn left at WI 76 and continue north to the roundabout at County O, right on O to the third property on your right.

FROM THE EAST OR WEST (Manitowoc, Stevens Point)

- Take US 10 toward the Fox Cities and exit at WI Highway 76 northbound.
- Follow WI 76 through Greenville and continue to the roundabout at County O, right on O to the third property on your right.

FROM THE HOTELS IN APPLETON

- Proceed west on College Avenue (County CA) until you reach the airport.
- Turn right on CB, then left on WI Highway 15 which is the end of the road.
- Proceed west on WI 15 to WI Highway 76 in Greenville, then turn right.
- You will continue north to the roundabout at County O, right on O to the third property on your right.
